#### OUR POLICIES

We issue and adhere to several internal policies to ensure we conduct business in an ethical and transparent manner. These include:

1. Corporate Social Responsibility Statement This details the core principles by which we operate our business.

The intention of this statement is to communicate our commitment to operate our business in a transparent and ethical manner including a zero-tolerance approach to any form of Modern Slavery within our supply chain.

- Anti-Slavery & Human Trafficking Policy
   This policy has been developed to reflect and communicate both internally and externally our
   commitment to implement and enforce effective systems and controls in order to identify and
   address any instances of modern slavery or human trafficking within our supply chains.
- 3. Recruitment

We operate a fair and open recruitment policy, including conducting eligibility to work in the UK checks for all employees to safeguard against human trafficking or individuals being forced to work against their will.

4. Employment

Our employment policies as detailed in our employee handbook, employment contracts and associated policies are in full compliance with UK legislation and ensure employees are provided with good working conditions, fair treatment and reasonable rates of pay and that we respect workers' human rights.

- Whistleblowing Policy This encourages all employees to raise confidentially any concerns relating to business conduct or activities.
- 6. Global Sourcing Agreement

Over the past few years we have continued to enhance our Global Sourcing Agreement which includes clear contractual obligations on our suppliers to comply with the Modern Slavery Act. We have also included the requirement that suppliers must not knowingly use any third party suppliers that do not comply with our requirements and that our suppliers are to advise the Company if they become aware of any instances of slavery or human trafficking within their supply chain.

#### DUE DILIGENCE AND ASSESSMENT OF RISK

We as a Company pride ourselves in trading ethically and maintain the measures built into our business process to address Modern Slavery within our supply chain. On an annual basis we conduct a formal Risk Assessment mapping all suppliers, agents, distributors, and customers and assess potential risk based on both industry/sector and geographical location. We also ensure that any new suppliers brought into our supply chain have been subject to full supplier approvement process.

Based on our assessment and understanding of our supply chain we recognise that our biggest exposure to Modern Slavery is within in our manufacturing supply chain, and as such we require all manufacturing suppliers to be members of SEDEX and undergo SMETA audits on an annual basis.

The Company have been a member of SEDEX (www.sedexglobal.com) since 2009. This is home to one of the world's largest collaborative platforms for buyers, suppliers and auditors to store, share and report on information quickly and easily. The platform is used by more than 40,000 members in over 150 countries to manage performance around labour rights, health & safety, the environment, and business ethics.

All our Tier 1 Manufacturing suppliers are registered on SEDEX and have annual SMETA audits, and we have enhanced our requirement for all manufacturing sites to complete 4 tier audits from 2019.

A review of audit compliance and conformance has been conducted as part of annual Modern Slavery Risk Assessment and findings will be communicated to suppliers to action and maintain continuous improvement in this area.

It is a requirement that all agencies engaged in the provision of temporary staff to the Company are licensed members of the Association of Labour Providers and for these agencies, we have introduced an audit programme to review their internal policies and commitment to address Modern Slavery.

During the current year we shall continue to place additional focus on agents/ distributors and employment agencies to enhance communication of our requirements and obligations under the Modern Slavery Act 2015.

### OUR EFFECTIVENESS IN COMBATING SLAVERY AND HUMAN TRAFFICKING

We work with all suppliers, agents, distributors and agencies to improve their ability to identify and prevent Modern Slavery. Forced Labour Reports shall continue to be used as a performance indicator.

We conduct a documented annual Risk Assessment designed to evaluate risk potential and establish actions for continual improvement.

We measure our effectiveness in combating Modern Slavery and Human Trafficking by evaluation of Risk Assessment findings for Tier 1 Manufacturing suppliers on an annual basis.

### TRAINING

To ensure a higher level of understanding of the risks of Modern Slavery and Human Trafficking, we will provide guidance to all employees based both in the UK and around the world.

In addition to this key staff involved in assessment of risk and implementing our policies shall maintain knowledge of modern slavery risks and identify opportunities for external training as appropriate.

We understand that Modern Slavery risk is not static, and we are committed to continue our approach to identify and mitigate this risk in the year ahead. We are making continuous improvements and amends.
